Introduction to Zhejiang University (ZJU)



Zhejiang University (ZJU) is a leading higher education institution in China, as well as one of its oldest. Its roots can be traced back to the founding of the Qiushi Academy in 1897.

Located in Hangzhou, one of China's most picturesque cities, ZJU consists of seven faculties and 40 schools. It is home to around 4,600 full-time faculty members, including 27 members of the Chinese Academy of Sciences and 21 members of the Chinese Academy of Engineering. Scholarship and Program Application

I. Application Deadline

Applicants should Complete Online Applications of both CSC system (https://studyinchina.csc.edu.cn/#/register) and ZJU system (https://isinfosys.zju.edu.cn/recruit/login.shtml) no later than December 31, 2024 (Beijing Time) and email all the documents to the Contact Person at APSCO.

III. Scholarship Coverage

- 1. Tuition waiver;
- 2. Free accommodation on campus or accommodation subsidy;
- 3. Stipend: Granted in accordance with the relevant standard;
- 4. Comprehensive Medical Insurance (Please refer to the relevant chapters in the application guide for details)

IV. Eligibility

1. Non-Chinese citizens with valid foreign passport;

- 2. Under the age of 35 for Master's program applicants and under the age of 40 for Doctoral program applicants. Applicants must be Bachelor's degree holders for Master's program applicants and must be Master's degree holders for Doctoral program applicants (Those who provide pre-graduation certificate or student status certificate at application MUST provide the required Bachelor's/Master's degree diploma no later than registration.)
- 3. With proper moral conduct, in good health with no infectious disease or any physical or mental disease that may affect the normal study;
- 4. Applicants who have given up their original Chinese citizenship (including residents in Hong Kong, Macao and Taiwan) and become foreign citizens shall provide the documents certifying the cancellation of Chinese citizenship and household registration;
- 5. If the applicant has acquired foreign citizenship automatically at the time of birth in a foreign country, whose parents were both Chinese citizens, or one of the parents was a Chinese citizen, parent's (with Chinese citizenship) permanent resident in foreign country should be obtained prior to the birth of the applicant;
 Note: If the applicant is concluded to have Chinese citizenship by the Chinese public security department after application, admission or enrollment, the applicant will be disqualified from application, admission or enrollment or withdrawal from school will be required.
- 6. Applicants should meet with Language Proficiency Requirements of Master/Doctoral Degree Programs at Zhejiang University for International Applicants. International applicants who apply for English-taught graduate programs must provide certificates to prove their English language proficiency meets the minimum requirement for admission, which are listed as below:
 - Applicants whose native language is English are exempt from providing English Proficiency Certificates. Native English-speaking countries

recognized by ZJU include: American Samoa, Australia, Bahamas, Barbados, Belize, Botswana, Canada, Fiji, Gibraltar, Ghana, Guyana, Ireland, Jamaica, Kenya, Lesotho, Liberia, New Zealand, Nigeria, Papua New Guinea, Singapore, Solomon Islands, South Africa, The Gambia, Tonga, United Kingdom (including Northern Ireland), United States of America, Zambia, Zimbabwe;

ii. Applicants whose native language is not English must provide English

iii. **Certificate of Instruction in English:** Applicants who have earned a degree from accredited college or university whose language of instruction was English, must provide Certificate of Instruction in English issued by previous institution.

Note: Applicants who apply for exemption from submitting language test scores must upload relevant documents to the **Language Proficiency Certificate Section** of ZJU Online Application System.

V. Application Documents and Process

- Applicants must firstly fill in and submit application via the CSC Online Application System (https://studyinchina.csc.edu.cn/#/register), and download the Application Form for Chinese Government Scholarship;
- 2. Applicants must log in to the Online Application System for International Students of Zhejiang University (https://isinfosys.zju.edu.cn/recruit/login.shtml), fill in clearly and upload completely the original or notarized scanned copies of the following materials as required:
 - i. A photocopy of passport front page. The expiry date of the passport should be after March 1, 2026;
 - ii. Highest degree certificates. Those who provide pre-graduation certificate
 or student status certificate at application MUST
 provide Bachelor's/Master's degree diploma no later than registration;
 - iii. Academic transcripts during Bachelor's degree/Bachelor's & Master's degree study;
 - iv. Language proficiency certificates;
 - Personal statement, in Chinese or English, should include study and work experience, reasons for application and study proposal. No less than 1500 words:
 - vi. Two letters of recommendation from full professors or associate professors. (Professors' signature, contact phone number and email address must be put on the letter.);
 - vii. 2025 version of Form for Provisional Acceptance of International Student by ZJU Supervisor. Applicants shall provide the above form for supervisors to fill. Old versions will not be accepted. Applicants of some programs must provide this form, please refer to the catalog of master's

- and doctoral degree programs.
- viii. Published academic papers or other academic achievements. (If applicable);
 - ix. Applicants are encouraged to provide GRE, NTS-GAT test score;
 - x. Applicants who have given up their original Chinese citizenship and become foreign citizens shall provide:
 - Documents certifying the cancellation of Chinese citizenship,
 - Documents certifying the cancellation of Chinese household registration,
 - Documents certifying the acquirement of foreign citizenship,
 - Self-Statement Form of Nationality Status and Nationality Confirmation and Guarantee Letter.
 - xi. If the applicant has acquired foreign citizenship automatically at the time of birth in a foreign country, whose parents were both Chinese citizens, or one of the parents was a Chinese citizen, shall provide:
 - Documents certifying acquiring foreign citizenship at the time of birth,
 - Documents certifying parent's (with Chinese citizenship) permanent residence in foreign country before the birth of the applicant,
 - Self-Statement Form of Nationality Status and Nationality Confirmation and Guarantee Letter.
- xii. Commitments for Zhejiang University Master/PhD Application. The PDF version of the Commitments must be clearly and completely filled out and hand-signed. Applications without the Commitments will not be accepted.

Note:

a) Please ensure that the passport submitted is your most recent one. If necessary, renew your passport in advance before submitting the application. Once admitted, the passport information cannot be changed until new semester registration. If the passport is replaced due to special circumstances or force

- majeure, a written explanation should be submitted to the university and consent must be obtained.
- b) After submitting the above materials in the online system, please pay the application fee in the system or upload the remittance voucher of the application fee.
- c) The above application materials must be in Chinese or English, and notarized copies of translations must be provided for texts in other languages.
- d) Please do NOT post the hard copies of the application materials or send them by e-mail, which will not be reviewed and processed.
- e) Supplementary materials may be required when necessary.
- f) If new policies are issued by superior departments, corresponding adjustments will be made.
- 3. In addition to the application documents required above, scholarship applicants must submit the following supplementary materials:
 - Application Form for Chinese Government Scholarship;
 - Photocopy of Foreigner Physical Examination Form. This form is uniformly printed by the Chinese health and quarantine department and needs to be filled out in English. The medical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the signature of the attending physician, the official stamp of the hospital or a sealed photograph of the applicants are invalid. In view of the fact that the examination results are valid for 6 months, applicants are requested to reasonably arrange the time for their physical examination accordingly.
 - **Non-Criminal Record Certificate**. The applicant shall submit a valid certificate of Non-Criminal Record issued by the local public security authority, usually issued within 6 months prior to the submission date of the application.

Note:

If applicants re-fill or modify the application information in CSC Online Application System after they have submitted the application, they need to send the updated Application Form for Chinese Government Scholarship to the admission email of Zhejiang University; otherwise the university may not be able to process the application.

VI. Application Fee

Application fee: RMB 800 yuan (non-refundable)

Application fee should be paid in the online application system of ZJU before deadline. One who fails to pay application fee, his or her application will not be processed.

VII. Selection Process, Admission and Notification

- The university will conduct a preliminary review of the applicant's materials.
 Those who pass the preliminary review will take video interview arranged by academic schools. The university enrollment will be made on the basis of competitive selection according to the applicants' research ability, academic performance, language proficiency, performance during video interview, etc.
- The name list of the scholarship awardees for postgraduate programs will be sent to China Scholarship Council for review within the specified period of time according to CSC's provisions.
- 3. After the name list is reviewed and approved by China Scholarship Council, the scholarship awardees will be notified by the university at the end of July or the beginning of August, 2025. The admission documents will be sent to the scholarship awardees afterwards.
- 4. Admission Notice can be downloaded from the Online Application System

(https://isinfosys.zju.edu.cn/recruit/login.shtml) from the end of July, 2025. Download link of the electronic Confirmation Form for Study in China (for visa) will be sent to the permanent email address filled in the application system by the applicant.

Note: Please check your account of ZJU application system frequently before the result comes out in case there may be requirements for supplementary documents submission.

VIII. Important Notes

- 1. Scholarship students' affairs are managed according to the relevant regulations of Chinese Government Scholarship.
- Scholarship students are not allowed to change their institutions as well as their academic programs or the duration of study specified in the Admission Notice.
- 3. The International College of Zhejiang University is responsible for the interpretation of the scholarship granting procedures and regulations.
- 4. For other requirements and contents of Chinese Government Scholarship, please visit the website of China Scholarship Council (https://www.campuschina.org/).

Registration

- 1. Master's/Doctoral degree programs of Zhejiang University usually start from the end of August or early September every year. For exact registration dates, please refer to the Admission Notice.
- 2. Admitted applicants must register with the university strictly according to the time specified in the admission notice. The original graduation certificate, original degree certificate, original language proficiency certificate will be checked upon registration. Those who fail to provide the corresponding certificates will be disqualified from enrollment.

Medical Insurance (Fee: RMB 800 Yuan/Academic year)

- According to the regulations of Ministry of Education, international students must purchase comprehensive medical insurance in the mainland of China as a necessary requirement for their registration for the new semester.
- 2. Students who fail to purchase the comprehensive medical insurance as required will NOT be registered by the university.
- 3. Information related to purchasing insurance will be notified in detail before registration.
